# **Duties and Responsibilities**

Performs executive and administrative duties, with technical/specialized knowledge, to manage a major division of the public services department that encompasses critical water quality systems & processes and a variety of city-owned facilities and physical assets. Major facilities include a Class A wastewater treatment plant and collection system, a water treatment plant and distribution system, city-owned surface infrastructure (streets) and a storm sewer system, city trails and park amenities, and assigned municipal buildings. Responsible for the administration, general supervision, operations and short and

long-term planning for the City's Streets and Parks. Responsible for assigning and directing work, monitoring and evaluating performance, recommending the hiring, transfer, suspension and discharge of employees, and recommending the adjustment of employee grievances. Manages division to promote the effective and efficient use of resources. Serves as the department's primary staff person to the Public Works Committee. The incumbent is expected to provide exemplary customer service to the community and direct work using environmentally-friendly or conscientious processes.
