## MINUTES CENTRAL SECTION MWOA MEETING GREEN LAKE SANITARY SEWER DISTRICT

## **APRIL 13, 2004**

The meeting was opened at 8:30 a.m. with a brief welcome by Gary Danielson, Kandiyohi County Public Works Director. He gave a detailed history of the installation of water and sewer around Green Lake and construction of the Green Lake Sanitary Sewer Treatment Plant.

Larry Zins from Command Central explained the Scada System and the benefits including it components and costs savings.

Brady Overton from US Filter discussed odor and corrosion control in collection systems.

- Understanding what causes odors
- Predicting sulfide generation
- Defining a system for control
- Selecting treatment

John McLouth from Tech Sales Co. presented new products including de-humidifies and odor control. Discussion included dissolved oxygen meters and the new aluminascent technology. No membranes or solution and is self calibrating. There is also a self calibrating clamp-on meter for liquid.

Sheila DeWolf from Bolton and Menk explained inflow and infiltration removal. She defined inflow and infiltration and reviewed some of the sources and solutions. In addition she explained some of the ordinances, sump pumps and inspection programs and benefits.

From W.W. Goetsch, Bryon Goehring presented the simplex packaged grinder pump station (similar to those installed in the Green Lake Sanitary Sewer District). His presentation included the pump's features, options, design and the uses.

Russ Noland from H20 Technical Services, Inc. talked on polymers and what's new and what they can do for your operation. He explained the chemistry, installation, uses and benefits.

The next session was on standby generator, options and maintenance. Mike Klein from Cummins North Central, Inc. explained maintenance for generators what should be checked on a weekly basis, including batteries, voltage regulator, radiator coolant, heaters, oil, filters, wet stacking, exercising machines once every two weeks and to keep the area clean.

John McCluth reported on Operator Certification. MPCA is currently rewriting the point system and will not see much change until then. There is a phosphorus removal course at the Dunwoody Institute instructed by Keith Redman.

Pat Meyer, Section Director updated on the Annual Conference to be held in Duluth, August 3-6, 2004. Members were encouraged to register early. He also mentioned that they are looking for persons to write articles for the Waste Watcher. At the board meeting they discussed the Gopher State One Calls and that the State is trying to request the City's be responsible to locate sewer service lines on private property. Members consented that there is no technology available to locate these lines.
