## Request for Proposal

### 1. Introduction

  - ii. LinkedIn
  - iii. Twitter

# 3. Scope of services

The scope of services to be included in your RFP are as follows. The services will be scalable, MWOA may elect to not do a portion of the scope:

- a. Initial kickoff meeting and consultation
- b. Website redesign as defined above
- c. Social media platform development
- d. Website hosting and maintenance

- iv. Website hosting and maintenance

  - b. Selection of vendor on January 10, 2021

  - c. Kickoff meeting on or before February 1, 2021d. Completion of scope of services on March 31, 2021
